घोटाळा नेमका काय ?

बाजारमंचाच्या- एक्स्टेंजच्या संगणकीय प्रणालीतील सधरेवरून शेअर दलालापर्यंत माहितीच्या प्रदान्याने प्रसारणाच्या अनुचित पद्धतीची अर्थात सह-स्थान घोटाल्याची सीबीआयद्वारे चौकशी सुरु आहे. सह-स्थान सुविधेमुळे दलालांना विशिष्ट जागा भाड्याने घेता येतात आणि ज्यायोगे त्यांच्या सर्व्हरची, एक्स्टेंज परिसरातच तेथील प्रणालीच्या सर्व्हरच्या सह-स्थितीत रचना करता येऊ शकली. यामुळे दलालांना व्यापारत प्राधान्याने प्रवेश मिळविता येऊन, इतरांच्या तुलनेत सहस्त्रांश सेकंद आधी सौदे करता येत असत.

मुंबई: जागतिक पतमानांकन संस्था मूडीजने अदानी समूहातील चार कंपन्यांसंबंधी दृष्टिकोन ‘स्थिर’वरून ‘नकारात्मक’ केल्याचे पडसाद म्हणून, समूहातील बाजारात सूचिबद्ध कंपन्यांचे समभाग सोमवारच्या सत्रातही घसरले. प्रमुख कंपनी अदानी एंटरप्रायझेसमध्ये सर्वाधिक ७ टक्क्यांची घसरण नोंदवली गेली. शुक्रवारी बाजारातील व्यवहार आटोपल्यानंतर प्रसिद्धीस दिलेल्या एका निवेदानाद्वारे, मूडीज इन्व्हेस्टर सर्व्हिसने अमेरिकास्थित हिंडेनबर्ग रिसर्चच्या अहवालानंतर बाजार मूल्यात तीव्र घसरण अनुभवाण्याच्या अदानी समूहाला आणखी एक धक्का मारानांतर बदलाचा निर्णय जाहीर केला. सोमवारी त्यावर गुंतवणूकदारांच्या नकारार्थी प्रतिक्रिया उमटल्या आणि संपूर्ण सत्रात अदानी समूहाच्या समभागवर दबाव होता. त्याचबरोबर निर्देशांक सेवा प्रदात्या ‘एमएससीआय’ने अदानी समूहातील चार कंपन्यांचे भारीक करी करणाऱ्या टारिफल्याने या समभागांमध्येही विक्रीचे पडसाद उमटले. ‘एमएससीआय’ने अदानी एंटरप्राइजेस, अदानी टोटल गॅस, अदानी ट्रान्समिशन, एसीसीएस सिमेंटच्या भारांकात कपात केली जाणार असल्याचे म्हटले आहे.
