Metalistic The Bombay High Court was on Thursday informed that the Union government has decided to set up an e-portal where manufacturers, distributors, chemists and realiers will have to register if they want to sell medicines online. The decision has been taken to regulate online sale of medicines. A division bench of Chief Justice Manjula Chellur and Justicen M Jamadar was hearing a PIL filed by city resident M Patti highlighting the issue of medicines heaving assign wantable online.



A 24-YEAR-OLD youth from A 24-PEN-CUL youth from Mumbai died after drowning in the Ghubad Lake near Lonavala, after he lost his balance and slipped on a rock under a local wa-ter fall on Thursday morning. This is the second death of a tourist near Lonavala in a week. The deceased has been iden-tified as Dhaval Visadhui Parmar.

tified as Dhawal Vijaybhai Parmar, a resident of Andheri, who had come to the hill station with his

friends for a picnic.

At 9.30 am, Parmar and his friends went to Lion's Point, lo-cated 10 kilometres from Lonavala town, and then to Ghubad Lake.

Anofficer fromthe Lonavala town police station said, "As perourpri-mary information, Parmar started climbing a rock under the water-fall and slipped. He fell into the water and could not swim as he had sustained injuries...his body was later pulled out of the water."

was later pulled out of the water. Afew days ago, a 22-year-old youth from Hadapsar, who was visiting Bhushi dam with his friends, died after he fell down while climbing a rock near awa-terfall. The police officer said, "Many of our staffers are de-ployed at these locations to man-age the flow of tourists and to warm them, acquist c firmbing the warn them against climbing the warn them against climbing the rocks as they are extremely slip-pery. Also, when it rains, the flow of water at these falls can sud-enly increase... These areas re-ceive very heavy rainfall and a sudden increase inwater flow can be dangerous anywhere. But tourists never listen and many a times, even argue with us...".
